

Installation of live equipment in secondary distribution boxes

Article Overview

Live equipment in secondary distribution boxes must be installed following strict safety, clearance, and standard compliance requirements to ensure operational reliability and personnel safety.

Key Considerations for Installation

1. **Safety and Standards Compliance** All live equipment must comply with international and regional standards, such as IEC and EN standards, and local electrical codes. Equipment should be CE marked where applicable, and installation must respect the Low Voltage Directive for voltages from 50-1000 V AC or 75-1500 V DC, ensuring protection against electric shock, fire, and electromagnetic interference . Only new, approved equipment should be installed; second-hand equipment requires formal written approval . 2. **Equipment Layout and Segregation** Secondary distribution boxes typically house MCCBs, fuses, residual current devices, and busbars. Adequate clearance around live components is essential for safe operation and maintenance. Equipment operating at different voltages should be segregated to prevent accidental contact and reduce fault propagation . Space must allow for cable entry, connection, and future expansion. 3. **Transformer and Busbar Integration** Secondary distribution boxes are often fed from 11 kV/400 V transformers in unit substations. Transformers should be close-coupled to minimize secondary cable lengths, reducing voltage drop and losses . Busbars must be rated for the expected load, and tie breakers may be used to allow selective switching between buses for reliability and maintenance. 4. **Protective Devices and Fault Management** Install circ...
